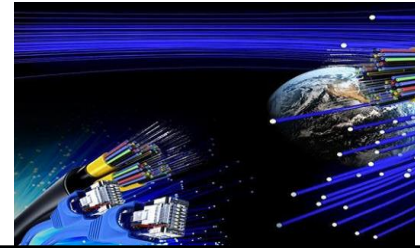

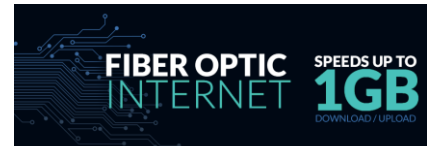

Today's study found that, for homes where 1 gigabit-per-second broadband was available, **transaction prices were over 7 percent higher** than homes located where the highest speed available is **25 Mbps** or lower.

2019 study done by RVA LLC revealed that consumers experience with fiber was 98% satisfaction compared to other mediums such as Cable, Wireless, DSL or satellite. FBA released a new metric called the Broadband Experience Index ("BEI"). The BEI, developed for FBA by Render Associates, is intended to give consumers a more comprehensive and reliable methodology for comparing broadband services in real-world applications rather than only measuring broadband based on speeds.

What Happens

When we receive the required commitment level construction begins.

The required commitment is 50% of the households committing by Sept 15.

There are over 300 households included in the design so we will continue to collect commitment until we reach 80%.

Monthly Subscriptions

50Mbps x 50Mbps	\$88
100Mbps x 100Mbps	\$128
1Gbps x 1Gbps	\$156

Seasonal plans

Requires a minimum 6 month commitment at the preferred plan rate.

Example 6 months at gig \$156 = \$936 for the months of May-June-July-Aug-Sept-Oct. The months of Nov-Dec-Jan-Feb-Mar-Apr are billed at lowest rate of \$88 per month = \$528. The **total due is \$1,464 a savings of \$408 providing a 21% savings.**

Why now?
